CRHS Student Report – Jeremy Cannon and Naomi Rinaldo

Jeremy and Naomi updated the Board about the success of Spam-A-Lot, spring sports starting, the trip to Spain with 9 students going to Madrid, Seville, Grenada, Cordova, Costa del Sol where they learned to flamenco dance, spent a day at the beach and explored. National Honor Society induction is next week with 28 juniors and 4 seniors. They also talked about the SBAC testing, saying this was a "test of the test". This has been good practice for teachers to work out the kinks.

Communications

Mrs. Flanagan reported that she played dodge ball for the benchwarmer's fundraiser. It was a lot of fun. Mrs. Buckheit said that the Wizard of Oz was being performed.

Presentations

Pension Review

Tim Ryor of Hooker & Holcomb handed out a presentation to the members and talked about the actuarial valuation. He said that the valuation is for the budget, to keep it funded over time. The benefits are fixed, investments vary. Region 13 is currently at a 7.5% long term rate of return which is average. You are 77% funded, which is above average in the state. In 2015 we will do an experience study. The NPL (Net Pension Liability) is \$1.37M.

Tom Forma from Merrill Lynch handed out a report. He said that they are a consultant and do not make any investment choices. For the 12-month period that just ended you are up 15%. You have 80% in high quality stocks that are very diverse. Short term bonds are under three years.

Mrs. Flanagan said that this is a lot for the full board and asked that he meet with the finance committee to discuss further.

Superintendent's Report

Tyler McDonald was one of 30 students chosen for an internship program at the Yale School of Medicine. The high school has redone the schedule for SBAC. There is no more 2-hour delay for sophomores. The original schedule was based on the recommendation of the state. It has been very important that the teachers have had the opportunity to administer the test. We will be in a better place next year. On May 16th, there will be a picnic lunch at Korn with the seniors from Durham and Middlefield. The district has been chosen randomly for a civil rights review from the state. Some of the recommendations could be costly. Dr. Veronesi stated there has been a request for starting a hockey club here. All fees would be incurred by the families. Our part would be to recognize their accomplishments. We lose kids to private schools if they are interested in hockey. The five students who are interested are currently playing in private clubs which is very expensive. Both boys and girls would be eligible to play in the co-op. The board does not have to vote on this, it is informational.

2014-2015 Budget Update

Mrs. Flanagan said that the Board voted to go forward with the 1.74% increase but asked for suggestions about what to do for the grade 3 and 5 class sizes.

Dr. Veronesi reported that the administration met and there will be a reallocation of resources in order to reinstate the two teachers for grades 3 and 5. It is a priority to deliver the curriculum.

Mr. Melnik said that after the referendum passes, they will come forward with the line items to be transferred.

Mrs. Flanagan will be in touch with the Town Times and Patch about the referendum and the change to add the two teachers. Adding the teachers is in the best interest of the students.

New Business

Child Nutrition Authorized Signer Form

Committee Reports Utilization Committee

Mr. Fulton said that the report from DRA has three recommendations. We will be meeting on each of the recommendations and will bring the summary to the Board and then to the community. We will be addressing the implications and looking at financing. The process will go through the summer.

Mrs. Flanagan said it is important to confirm what has to be done in each building regardless of the recommendations. This study has given us a great view of the buildings and mechanicals. We will be able to put together a great capital plan going forward. We will be meeting on May 6th from 10 a.m. – 12 p.m., May 14th from 8 – 10 a.m., and May 29th from 3 – 5 p.m. Given the time tonight, we will reschedule the Policy and Human Resource Committee Meetings.
